Summary

No Sustainable investment objective

This financial product promotes environmental or social characteristics, but does not have as its objective sustainable investment.

Environmental or social characteristics of the financial product

The Fund promotes the social characteristic of avoiding investments in certain activities which can cause harm to human health and wellbeing or be damaging to social cohesion. The Fund also excludes certain companies which have experienced notable sustainability-related controversies, or which are in violation of international norms (unless, in each case, the Investment Adviser considers that the company is taking appropriate steps for material remediation and improvement).

Investment Strategy

The US Property Fund's investment objective is to seek long term capital appreciation by investing primarily in equity securities of companies in the US real estate industry located in the US. The Fund meets its environmental and social characteristics through the application of social exclusions and international norms exclusions, as described further below.

As part of its bottom-up, fundamental research process, the Investment Adviser systematically incorporates an assessment of an issuer's corporate governance and business practices.

At least 80% of the Fund's investments are aligned with environmental or social characteristics. These investments offer direct exposure to investee entities, including investments in real estate investment trusts (or REITs).

These percentages are measured according to the value of the investments.

Monitoring of environmental or social characteristics

The environmental and social characteristics are monitored using a combination of tools/screens, portfolio surveillance tools and manual desk reviews and analysis.

The Investment Adviser's Compliance, Risk and Portfolio Surveillance teams collaborate with the investment team to conduct regular portfolio/performance reviews and systemic checks to ensure compliance with portfolio investment objectives and environmental and social characteristics.

Methodologies

The application of the exclusionary screens to the Fund's investments is measured by the percentage of the Fund's investments which breach the exclusionary screens. The relevant sustainability indicator monitored by the Fund is therefore that 0% of the Fund's investments are in violation of the exclusionary screens.

Data sources and processing

The Investment Adviser leverages ESG data from various external vendors. This data is collected and stored in Morgan Stanley's centralized ESG data repository, to allow any Morgan Stanley business unit, including MSIM investment teams, to access the information for research, portfolio analysis and construction, and client and regulatory reporting. Due to gaps in data coverage, a small proportion of the data which is used to assess alignment with environmental / social characteristics is estimated data.

Limitations to methodologies and data

The below outlines some of the key themes and commonalities which contribute to limitations in the methodologies and/or data and/or poor data quality of the Fund:

- methodology differences between data providers;
- data lags i.e., reporting timelines for data may not align with SFDR reporting timelines; and

- data coverage gaps across asset classes, geographies, and market capitalisations.

The Investment Adviser takes reasonable steps to ensure that the Fund is able to meet its environmental or social characteristics despite these limitations.

Due diligence

The investment team responsible for the Fund undertakes a mosaic approach to sustainability research, using both quantitative and qualitative data from various sources, both internal and external. The investment team's proprietary research process results in a scorecard that ranks the relative strengths and weaknesses of each company in the investment universe on ESG factors. The team then adjusts its valuations of the companies to account for these ESG risks and opportunities, and the impact they may have on a company's net asset value and cash flow forecasts in both the near and intermediate term. Investors should note, however, that the output of this scorecard process is not binding on the Investment Adviser's selection of investments for the Fund (unlike the binding exclusions applicable to the Fund).

As part of its due diligence processes, the Fund's proposed investments are screened for compliance with the Fund's binding exclusionary screens and international norms exclusions. A company that is flagged in pre-trade compliance will not be permitted to be purchased by the Fund (unless, with respect to international norms exclusions, the Investment Adviser considers that the company is taking appropriate steps for material remediation and improvement).

Engagement policies

The investment team generally engages with company management at regular intervals and, in doing so, seeks to drive positive change, improve sustainability and enhance long-term value creation. As part of this engagement process, the investment team assesses how company ESG risks and initiatives may contribute to operating performance, and through conversation evaluate a range of environmental, social and governance topics.

Designated reference benchmark

The Fund has not designated a reference benchmark for the purpose of attaining its environmental or social characteristics.

No Sustainable investment objective

This financial product promotes environmental or social characteristics, but does not have as its objective sustainable investment.

Environmental or social characteristics of the financial product

The Fund promotes the social characteristic of avoiding investments in certain activities which can cause harm to human health and wellbeing or be damaging to social cohesion. The Fund also excludes certain companies which have experienced notable sustainability-related controversies, or which are in violation of international norms.

Investment Strategy

The US Property Fund's investment objective is to seek long term capital appreciation by investing primarily in equity securities of companies in the real estate industry or closely related to the real estate industry located in the US. The investment process utilizes internal proprietary research to invest in public real estate companies that may offer the best relative value relative to their underlying assets and earnings.

Investment strategy used to meet the environmental or social characteristics of the Fund

The binding elements of the Fund's investment strategy that are used to meet the environmental and social characteristics that the Fund promotes are described below.

Social exclusions: The Fund shall not knowingly invest in any company which derives more than 10% of company revenue from any one of the following activities:

- owning or operating real estate used for for-profit prisons;
- owning or operating real estate used to manufacture cannabis;
- manufacturing or production of tobacco;
- manufacturing or production of coal mining;
- manufacturing or production of controversial weapons and civilian firearms; and
- manufacturing or production of arctic oil and gas.

International norms exclusions: In addition, the Fund shall not knowingly invest in the following companies:

- companies that have experienced a notable sustainability-related controversy related to their operations and/or products, where the severity of the social or environmental impact of the controversy is above a certain threshold based on third party data, unless the Investment Adviser considers that the company is taking appropriate steps for material remediation and improvement;
- companies that fail to comply with the UN Global Compact or the ILO fundamental principles, unless the Investment Adviser considers that the company is taking appropriate steps for material remediation and improvement; and
- companies that do not have at least one female board member.

No minimum reduction rate has been defined in relation to the Fund's scope of investments.

However, the Investment Adviser anticipates that the application of

- the social exclusions described above will reduce the scope of the Fund's investments by up to 1%; and
- the international norms exclusions described above will reduce the scope of the Fund's investments by up to 1%.

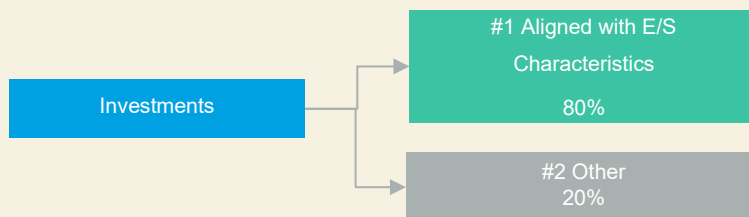
The anticipated reduction figures above are by market capitalisation of the Fund's potential investment universe.

Good governance

In addition, to seek to ensure that investee companies exhibit good standards of governance, the Investment Adviser incorporates as part of its bottom-up research process an assessment of an issuer's corporate governance and business practices, including but not limited to evidence of sound management structures and employee relations, fair remuneration of staff, and tax compliance, in order to ensure that every investee company follows good governance practices.

This is done through the monitoring of data on governance-related, as well as on other environmental and/or social factors and controversies, sourced from third party providers, through in-house research, and through engagement with the management of selected issuers on corporate governance and disclosure issues.

Proportion of investments



#1 Aligned with E/S characteristics includes the investments of the financial product used to attain the environmental or social characteristics promoted by the financial product.

#2 Other includes the remaining investments of the financial product which are neither aligned with the environmental or social characteristics, nor are qualified as sustainable investments.

At least 80% of the Fund's investments align with the environmental and social characteristics it promotes, through the application of the above-mentioned exclusions. These investments offer direct exposure to investee entities, including investments in real estate investment trusts (or REITs), and the Fund therefore expects to meet its environmental and social characteristics wholly through investments that offer direct exposure to investee entities.

A maximum of 20% of the Fund may be invested in hedging and/or cash instruments, which do not align with any environmental or social characteristics and are not subject to any minimum environmental or social safeguards.

These percentages are measured according to the value of the investments.

Monitoring of environmental or social characteristics

The sustainability indicators of the Fund will be measured and evaluated on an ongoing basis, using a combination of tools/screens, portfolio surveillance tools and manual desk reviews and analyses, which utilise in-house and third-party data. Screening of E/S exclusions will be coded into the portfolio surveillance system and may be sourced by third-party systems (MSCI ESG and FactSet) or internal analysis. The investment team will be notified if a company is flagged in the surveillance system (pre and post-trade monitoring) and breaches compliance. A company that is flagged in pre-trade compliance will not be permitted to be purchased by the Fund (unless, with respect to international norms exclusions, the Investment Adviser considers that the company is taking appropriate steps for material remediation and improvement).

If a company already held in the Fund flags on a restricted list in post-trade compliance, the investment team is notified and will take appropriate action. If the company experienced a notable sustainability-related controversy related to their operations and/or products, where the severity of the social or environmental impact of the controversy is above a certain threshold based on third party data, and the Investment Adviser considers that the company is taking appropriate steps for material remediation and improvement, they may choose to continue to hold the company in the Fund. Otherwise, the Investment Adviser will sell shares held of the company.

The investment process is subject to regular review, as part of a control and monitoring framework implemented by the Investment Adviser. The Investment Adviser's Compliance, Risk and Portfolio Surveillance teams collaborate with the investment team to conduct regular portfolio/performance reviews and systemic checks to ensure compliance with portfolio investment objectives and environmental and social characteristics, taking into account changing market conditions, information and strategy developments.

Methodologies

The application of the exclusionary screens to the Fund's investments is measured by the percentage of the Fund's investments which breach the exclusionary screens. The relevant sustainability indicator is therefore that 0% of the Fund's investments are in violation of the Fund's exclusionary screens.

Data sources and processing

The Investment Adviser uses internal data (in respect of the application of the Fund's exclusionary screens to exclude companies which derive more than 10% of their revenue from owning or operating real estate used for prisons) and leverages ESG data from various external vendors, which include: MSCI, ISS ESG, S&P Global Trucost, amongst others, in order to attain and monitor the environmental and social characteristics of the Fund. This data is collected and stored in Morgan Stanley's centralised ESG data repository, to allow any Morgan Stanley business unit, including MSIM investment teams, to access the information for research, portfolio analysis and construction, and client and regulatory reporting. A formal change management process is also in place to allow for enhancements as data quality/reporting improves.

Morgan Stanley also leverages third-party data in order to produce proprietary insights.

MSIM assesses data quality by liaising with the different data providers to obtain updates to the datasets as the regulation evolves. They also ensure that ESG data adheres to the Firm's data governance and quality standards through procedures to assess the appropriateness and delivery of data feeds. MSIM also conducts, as appropriate, due diligence on the external data providers in order to assess whether their methodologies are appropriate for the intended use case.

In general, third-party ESG data is centralised at Morgan Stanley for broad consumption across the organisation, including the MSIM business. As part of this centralisation process, data is vetted with quality

control checks on a recurring basis to ensure data provider feeds are accurate, timely and, where needed, merged with existing firm infrastructure, identifiers and/or expanded to improve issuer coverage.

A small proportion of the data which is used to assess alignment with E/S characteristics is estimated. The Investment Adviser estimates this data due to a lack of availability of reliable data. The Investment Adviser will keep this lack of data under review and replace the estimated data with third-party data sources or data obtained by other means (e.g., directly from investee companies) when available.

Limitations to methodologies and data

The below outlines some of the key themes and commonalities which contribute to limitations in the methodologies and/or data and/or poor data quality of the Fund:

- methodology differences between data providers
- data lags i.e., reporting timelines for data may not align with SFDR reporting timelines
- data coverage gaps across asset classes, geographies, and market capitalisations

Despite these limitations, which impact all consumers of ESG data and are not specific to MSIM, the Investment Adviser takes reasonable steps to ensure that these factors do not have a negative impact on the E/S characteristics of the fund, for example, the Investment Adviser looks beyond subjective ESG ratings and evaluates an extensive set of raw ESG data points on companies that cover controversies, products and practices, revenue involvement and sustainable alignment that help inform the E/S characteristics of the investments more holistically. For example, the investment team generally has regular touchpoints with company management, and any discrepancies the investment team identifies between those discussions as well as supplemental reports/marketing materials provided by the company as compared to third party ESG data may be escalated to the MSIM sustainability team, portfolio surveillance and the ESG 3rd party service provider as required.

Due diligence

The investment team responsible for the Fund undertakes a mosaic approach to sustainability research which includes using both quantitative and qualitative data from multiple sources. As part of this approach, research analysts adjust company valuations to account for ESG risks and opportunities in their model valuations, and the impact ESG factors may have on a company's net asset value and cash flow forecasts in both the near and intermediate term. Internal research is used to complement and enhance data from company sustainability reports and third-party providers including MSCI, ISS, Sustainalytics and the Global Sustainability Real Estate Benchmark.

The investment team's proprietary research process results in a scorecard that ranks the relative strengths and weaknesses of each company in the investment universe on ESG factors. The team pulls ESG ratings from third-party providers (via Bloomberg and GRESB) to standardize the various ratings for a company into a 10-point score which then ranks the universe on available metrics to get a better sense of relative strength. The outcomes are used by the investment team to adjust its view on the valuations of investee companies, to account for these ESG risks and opportunities and the impact they may have on a company's net asset value (where relevant) and cash flow forecasts, in both the near and intermediate term. Investors should note, however, that the output of this scorecard process is not binding on the Investment Adviser's selection of investments for the Fund (unlike the binding exclusions applicable to the Fund, which are described above).

As part of its due diligence processes, the Fund's proposed investments are screened for compliance with the Fund's binding exclusionary screens, including the international norms exclusions. A company that is flagged in pre-trade compliance will not be permitted to be purchased by the Fund (unless, with respect to

international norms exclusions, the Investment Adviser considers that the company is taking appropriate steps for material remediation and improvement), as further described in 'monitoring of environmental and social characteristics' above.

Investors should note, however, that neither the output of the assessment of the portfolio company ESG weaknesses nor a company's ESG score are binding on the Investment Adviser's selection of investments for the Fund (unlike the binding exclusions applicable to the Fund, which are described above).

Engagement policies

A key input in the investment selection process for the Fund is a deep understanding of management quality. In order to manage ESG-related risks and opportunities, the investment team for the Fund generally engages with company management at regular intervals, including engaging in active dialogues where the Fund holds significant positions in a company and issues are viewed as material. The team's constructive dialogue seeks to drive positive change, improve sustainability and enhance long-term value creation. As part of this ESG engagement, the investment team assess how company ESG risks and initiatives will contribute to operating performance, and through conversation evaluate a range of environmental, social and governance topics.

Regular engagements with company management provide an opportunity to monitor and track the performance of the Fund's investments. The investment team and the Global Stewardship Team regularly monitor and engage with companies throughout the investment process and maintain engagement records to track progress and to allow engagement insights to be incorporated in investment decisions.

An engagement is considered to be successful when a company is receptive to the Investment Adviser's viewpoints and suggestions and takes concrete steps to implement them. In cases where a company is not receptive or where engagements do not lead to desired results, the Investment Adviser may escalate our engagement by, for example, casting votes against management, requesting meetings with board members, or via additional communication with boards and management. In some cases, repeated, unsuccessful engagements in relation to a material issue may contribute to a decision to decrease or exit a holding.

The need for escalation and types of escalation methods used depends on the investment, prior engagement activities, outlook and a judgement call as to the materiality of the issue at hand, whilst always putting investors' interests at the forefront of decision-making. As active owners, the Investment Adviser already has regular touchpoints with portfolio companies/issuers. However, the Investment Adviser also appreciates that each engagement is unique to the particular company and therefore it does not rely on a prescriptive engagement escalation framework. Therefore, in some cases, it may take years to effect substantive change on certain issues.

Zusammenfassung

Kein nachhaltiges Investitionsziel

Dieses Finanzprodukt bewirbt ökologische oder soziale Merkmale, hat jedoch keine nachhaltige Investition zum Ziel.

Ökologische oder soziale Merkmale des Finanzprodukts

Der Fonds bewirbt das soziale Merkmal des Ausschlusses von Investitionen in Aktivitäten, die schädlich für Gesundheit und Wohlergehen von Menschen sein können. Der Fonds schließt auch bestimmte Unternehmen aus, die erhebliche nachhaltigkeitsbezogene Kontroversen aufweisen oder gegen internationale Normen verstoßen (es sei denn, der Anlageberater ist der Ansicht, dass das Unternehmen angemessene Maßnahmen zur Behebung und Verbesserung ergreift).

Anlagestrategie

Das Anlageziel des Fonds ist ein langfristiger Kapitalzuwachs, in erster Linie durch die Anlage in Aktien von Unternehmen der US-Immobilienbranche mit Sitz in den USA. Der Fonds erfüllt seine ökologischen und sozialen Merkmale, indem er soziale Ausschlüsse und Ausschlüsse auf Basis internationaler Normen anwendet, wie weiter unten ausführlicher beschrieben.

Im Rahmen seines Verfahrens der Bottom-up-Fundamentalanalyse bezieht der Anlageberater systematisch eine Bewertung der Unternehmensführung und der Geschäftspraktiken der Emittenten ein.

Mindestens 80 % der Investitionen sind auf ökologische oder soziale Merkmale ausgerichtet.

Diese Anlagen bieten ein direktes Engagement in Portfoliounternehmen, darunter auch Anlagen in Real Estate Investment Trusts (REITs).

Diese Prozentanteile werden gemäß dem Anlagewert gemessen.

Überwachung der ökologischen oder sozialen Merkmale

Die ökologischen und sozialen Merkmale werden durch Tools/Filter, Portfolioüberwachungs-Tools und manuelle Überprüfungen und Analysen des Teams überwacht.

Die Compliance-, Risiko- und Portfolioüberwachungsteams des Anlageberaters arbeiten mit dem Anlageteam zusammen, um regelmäßige Portfolio-/Performanceüberprüfungen und systemische Kontrollen durchzuführen, um die Compliance mit den Anlagezielen sowie den ökologischen und sozialen Merkmalen des Portfolios sicherzustellen.

Methoden

Die Anwendung der Ausschlussfilter auf die Anlagen des Fonds wird am Anteil der Anlagen des Fonds gemessen, die gegen die Ausschlussfilter verstoßen. Der relevante Nachhaltigkeitsindikator lautet daher dahingehend, dass 0% der Anlagen des Fonds gegen die Ausschlussfilter verstoßen.

Datenquellen und -verarbeitung

Der Anlageberater nutzt ESG-Daten verschiedener externer Anbieter. Diese Daten werden im zentralisierten ESG-Datenspeicher von Morgan Stanley gesammelt und gespeichert, sodass alle Geschäftseinheiten von Morgan Stanley, darunter auch die Anlageteams von MSIM, Zugang zu diesen Informationen für Research, Portfolioanalyse und -konstruktion sowie die Berichterstattung an Kunden und Aufsichtsbehörden haben. Aufgrund von Lücken bei der Datenabdeckung handelt es sich bei einem kleinen Anteil der Daten, die zur Bewertung der Compliance mit Umwelt-/sozialen Merkmalen eingesetzt werden, um Schätzungen.

Beschränkungen hinsichtlich der Methoden und Daten

Im Folgenden werden einige der wichtigsten Themen und Gemeinsamkeiten aufgeführt, die zu Einschränkungen für Methodologien und/oder

Daten und/oder mangelhafter Datenqualität des Fonds beitragen:

- unterschiedliche Methoden der einzelnen Datenanbieter,
- zeitliche Verzögerungen, d. h. die Fristen für die Berichterstattung stimmen unter Umständen nicht mit denen der SFDR überein, und
- Lücken bei der Datenabdeckung über Anlageklassen, Regionen und Marktkapitalisierungen hinweg.

Der Anlageberater ergreift angemessene Maßnahmen, um sicherzustellen, dass der Fonds seine ökologischen oder sozialen Merkmale trotz dieser Einschränkungen erfüllen kann.

Sorgfaltspflicht

Das Anlageteam des Fonds verfolgt einen mosaikartigen Ansatz beim Nachhaltigkeitsresearch und verwenden qualitative und quantitative Daten aus mehreren internen und externen Quellen. Das proprietäre Researchverfahren des Anlageteams ergibt eine Scorecard, die die relativen Stärken und Schwächen jedes Unternehmens im Anlageuniversums auf ESG-Ebene bewertet. Das Team passt seine Bewertungen der Unternehmen an, um diese ESG-Risiken und -Chancen sowie ihre kurz- und mittelfristigen Auswirkungen auf den Nettoinventarwert und den prognostizierten Cashflow des Unternehmens zu berücksichtigen. Anleger sollten sich jedoch bewusst sein, dass das Ergebnis dieses Scorecard-Prozesses für die Anlageauswahl des Anlageberaters für den Fonds nicht verbindlich ist (im Gegensatz zu den obligatorischen Ausschlüssen, die für den Fonds gelten).

Im Rahmen seiner Due Diligence werden die geplanten Anlagen des Fonds in Bezug auf die Compliance mit den obligatorischen Ausschlussfiltern des Fonds und den auf internationalen Normen basierenden Ausschlüssen gefiltert. Ein Unternehmen, das bei der Pre-Trade-Compliance angezeigt wird, kann vom Fonds nicht erworben werden (es sei denn, der Anlageberater ist in Bezug auf Ausschlüsse, die auf internationalen Normen beruhen, der Ansicht, dass das Unternehmen angemessene

Maßnahmen zur Behebung und Verbesserung ergreift).

Mitwirkungspolitik

Das Anlageteam setzt sich normalerweise mit der Geschäftsleitung regelmäßig in Kontakt, um positive Veränderungen zu fördern, die Nachhaltigkeit jedes Unternehmens zu verbessern und die langfristige Wertschöpfung zu steigern. Im Rahmen dieses Prozesses bewertet das Anlageteam, wie die ESG-Risiken und -Chancen des Unternehmens zur operativen Performance beitragen können. In Gesprächen werden verschiedene ESG-Themen (Umwelt, Soziales, Governance) bewertet.

Bestimmter Referenzwert

Der Fonds hat keinen Referenzwert für das Erreichen seiner ökologischen oder sozialen Merkmale bestimmt.

Επενδυτική στρατηγική

Ο επενδυτικός στόχος του Αμοιβαίου Κεφαλαίου είναι να επιδιώκει μακροπρόθεσμη υπεραξία κεφαλαίου, επενδύοντας κυρίως σε μετοχικούς τίτλους εταιρειών από τον κλάδο των ακινήτων των ΗΠΑ που εδρεύουν στις ΗΠΑ. Το Αμοιβαίο Κεφάλαιο ανταποκρίνεται στα περιβαλλοντικά και κοινωνικά χαρακτηριστικά του μέσω της εφαρμογής κοινωνικών αποκλεισμών και αποκλεισμών βάσει διεθνών κανόνων, όπως περιγράφεται αναλυτικότερα παρακάτω.

Στο πλαίσιο της θεμελιώδους «bottom-up» (από τη βάση προς την κορυφή) ερευνητικής διαδικασίας, ο Σύμβουλος Επενδύσεων ενσωματώνει συστηματικά μια αξιολόγηση της εταιρικής διακυβέρνησης και των επιχειρηματικών πρακτικών ενός εκδότη.

Τουλάχιστον το 80% των επενδύσεων του Αμοιβαίου Κεφαλαίου είναι ευθυγραμμισμένο με περιβαλλοντικά ή κοινωνικά χαρακτηριστικά. Οι επενδύσεις αυτές προσφέρουν απευθείας έκθεση σε οντότητες στις οποίες επενδύει το Αμοιβαίο Κεφάλαιο, συμπεριλαμβανομένων επενδύσεων σε εταιρείες επενδύσεων σε ακίνητα (REIT).

Τα ποσοστά αυτά υπολογίζονται σύμφωνα με την αξία των επενδύσεων.

Παρακολούθηση περιβαλλοντικών ή κοινωνικών χαρακτηριστικών

Τα περιβαλλοντικά και κοινωνικά χαρακτηριστικά παρακολουθούνται χρησιμοποιώντας έναν συνδυασμό εργαλείων/ελέγχων, εργαλείων επιτήρησης χαρτοφυλακίου και χειροκίνητων επισκοπήσεων και αναλύσεων.

Οι ομάδες κανονιστικής συμμόρφωσης, κινδύνων και εποπτείας χαρτοφυλακίου του Συμβούλου Επενδύσεων συνεργάζονται με την επενδυτική ομάδα για τη διενέργεια τακτικών επισκοπήσεων χαρτοφυλακίου/απόδοσης και συστημικών ελέγχων προκειμένου να διασφαλίζεται η συμμόρφωση με τους επενδυτικούς στόχους του χαρτοφυλακίου και τα περιβαλλοντικά και κοινωνικά χαρακτηριστικά.

Μεθοδολογίες

Η εφαρμογή των ελέγχων αποκλεισμού στις επενδύσεις του Αμοιβαίου Κεφαλαίου μετράται με βάση το ποσοστό των επενδύσεων του Αμοιβαίου Κεφαλαίου που παραβιάζουν τους ελέγχους αποκλεισμού. Πηγές και επεξεργασία δεδομένων

Ο Σύμβουλος Επενδύσεων αξιοποιεί δεδομένα ESG από διάφορους εξωτερικούς προμηθευτές. Τα δεδομένα αυτά συλλέγονται και αποθηκεύονται στο κεντρικό αποθετήριο δεδομένων ESG της Morgan Stanley, ώστε οποιαδήποτε επιχειρηματική μονάδα της Morgan Stanley, συμπεριλαμβανομένων των επενδυτικών ομάδων MSIM, να έχει πρόσβαση στις πληροφορίες για σκοπούς έρευνας, ανάλυσης και δημιουργίας χαρτοφυλακίου, καθώς και υποβολής εκθέσεων σε πελάτες και κανονιστικές αρχές. Λόγω κενών στην κάλυψη των δεδομένων, ένα μικρό ποσοστό των δεδομένων που χρησιμοποιούνται για την αξιολόγηση της ευθυγράμμισης με τα περιβαλλοντικά/κοινωνικά χαρακτηριστικά είναι κατ' εκτίμηση δεδομένα.

Περιορισμοί μεθοδολογιών και δεδομένων

Παρακάτω περιγράφονται ορισμένα από τα βασικά θέματα και τα κοινά σημεία που συμβάλλουν στους περιορισμούς των μεθοδολογιών ή/και των δεδομένων ή/και στην κακή ποιότητα των δεδομένων του αμοιβαίου κεφαλαίου:

Ο Σύμβουλος Επενδύσεων λαμβάνει εύλογα μέτρα για να διασφαλίσει ότι το Αμοιβαίο Κεφάλαιο είναι σε θέση να ανταποκριθεί στα περιβαλλοντικά ή κοινωνικά χαρακτηριστικά του παρά τους εν λόγω περιορισμούς.

Δέουσα επιμέλεια

Η επενδυτική ομάδα που είναι υπεύθυνη για το Αμοιβαίο Κεφάλαιο υιοθετεί μια ετερόκλητη προσέγγιση για την έρευνα βιωσιμότητας που πραγματοποιεί, χρησιμοποιώντας τόσο ποσοτικά όσο και ποιοτικά δεδομένα από διάφορες εσωτερικές και εξωτερικές πηγές. Από την ιδιόκτητη ερευνητική διαδικασία της επενδυτικής ομάδας προκύπτει ένας πίνακας βαθμολογίας, όπου κατατάσσονται τα σχετικά πλεονεκτήματα και μειονεκτήματα κάθε εταιρείας του επενδυτικού περιβάλλοντος με βάση παράγοντες ESG. Στη συνέχεια, η ομάδα προσαρμόζει τις αποτιμήσεις των εταιρειών λαμβάνοντας υπόψη αυτούς τους κινδύνους και τις ευκαιρίες ESG, καθώς και τον αντίκτυπο που μπορεί να έχουν στις βραχυπρόθεσμες και τις μεσοπρόθεσμες προβλέψεις για την καθαρή αξία ενεργητικού και την ταμειακή ροή των εταιρειών. Ωστόσο, οι επενδυτές θα πρέπει να έχουν υπόψη ότι το αποτέλεσμα αυτής της διαδικασίας βαθμολόγησης δεν είναι δεσμευτικό για την επιλογή επενδύσεων του Αμοιβαίου Κεφαλαίου από τον Σύμβουλο Επενδύσεων (σε αντίθεση με τους δεσμευτικούς αποκλεισμούς που ισχύουν για το Αμοιβαίο Κεφάλαιο).

Πολιτικές ενεργούς συμμετοχής

Η επενδυτική ομάδα γενικά συνεργάζεται τακτικά με τις διοικήσεις εταιρειών και, στο πλαίσιο αυτό, επιδιώκει να ωθεί θετικές αλλαγές, να βελτιώνει τη βιωσιμότητα και να ενισχύει τη μακροπρόθεσμη δημιουργία αξίας. Στο πλαίσιο αυτής της διαδικασίας ενεργούς συμμετοχής, η επενδυτική ομάδα αξιολογεί το πώς οι κίνδυνοι και οι πρωτοβουλίες ESG μπορούν να συμβάλουν στην απόδοση λειτουργίας και, μέσω συζητήσεων, αξιολογείται μια σειρά θεμάτων ESG.

Resumen

Sin objetivo de inversión sostenible

Este producto financiero promueve características medioambientales o sociales, pero no tiene como objetivo una inversión sostenible.

Características medioambientales o sociales del producto financiero

El fondo promueve la característica social de evitar inversiones en determinadas actividades que pueden ser perjudiciales para la salud y el bienestar de los seres humanos o para la cohesión social. El fondo también excluye determinadas compañías que han experimentado controversias destacadas relacionadas con la sostenibilidad o que infringen normas internacionales (, salvo, en cada caso, que el asesor de inversiones considere que la compañía está tomando medidas adecuadas para su oportuna subsanación y mejora).

Estrategia de inversión

El objetivo de inversión de US Property Fund es procurar la revalorización del capital a largo plazo invirtiendo principalmente en títulos de renta variable de compañías del sector inmobiliario estadounidense ubicadas en Estados Unidos. El fondo cumple sus características medioambientales y sociales aplicando exclusiones sociales y por razón de incumplimiento de normas internacionales, según se describe más detalladamente a continuación.

En el marco de su proceso bottom-up de análisis fundamental, el asesor de inversiones lleva a cabo sistemáticamente una evaluación del gobierno corporativo y las prácticas empresariales del emisor.

Al menos, el 80% de las inversiones del fondo son conformes con características medioambientales o sociales. Estas inversiones ofrecen exposición directa a las compañías en las que se invierte, incluidas inversiones en fondos de inversión inmobiliaria (o REIT).

Estos porcentajes se cuantifican de acuerdo con el valor de las inversiones.

Seguimiento de las características medioambientales o sociales

Las características medioambientales o sociales se controlan utilizando una combinación de herramientas/controles, medios de supervisión de las carteras y revisiones y análisis manuales.

Los equipos de cumplimiento, riesgo y supervisión de carteras del asesor de inversiones colaboran con el equipo de inversión para llevar a cabo revisiones periódicas de la cartera / el rendimiento y comprobaciones sistémicas para asegurar el cumplimiento de los objetivos de inversión de la cartera y las características medioambientales y sociales.

Métodos

La aplicación de los controles de exclusión a las inversiones del fondo se cuantifica según el porcentaje de las inversiones del fondo que los incumplen. El indicador de sostenibilidad correspondiente que sigue el fondo es, por tanto, que el 0% de las inversiones del fondo contravengan los controles de exclusión.

Fuentes y tratamiento de datos

El asesor de inversiones recurre a datos ESG de varios proveedores externos. Estos datos se recogen y se almacenan en el depósito centralizado de datos ESG de Morgan Stanley para permitir a la unidad de negocio de Morgan Stanley, incluidos los equipos de inversión de MSIM, acceder a la información para realizar estudios, llevar a cabo análisis y elaboración de carteras, y facilitar información a clientes y reguladores. Debido a las carencias en la cobertura de los datos, una pequeña proporción de los datos que se utilizan para evaluar el cumplimiento de las características medioambientales/sociales corresponde a datos estimados.

Limitaciones de los métodos y los datos

A continuación, se describen algunos de los temas y los aspectos comunes clave que contribuyen a las limitaciones en los métodos y/o los datos y/o la calidad deficiente de los datos del fondo:

- diferencias en los métodos entre proveedores de datos;
- lapsos en los datos, es decir, los calendarios de provisión de datos podrían no ajustarse a los que establece el SFDR; y
- carencias en la cobertura de los datos entre clases de activos, regiones y capitalizaciones de mercado.

El asesor de inversiones toma medidas razonables para velar por que el fondo pueda cumplir sus características medioambientales o sociales a pesar de estas limitaciones.

Diligencia debida

El equipo de inversión responsable del fondo aplica un enfoque tipo mosaico hacia el análisis de la sostenibilidad, aplicando datos tanto cuantitativos como cualitativos procedentes de diversas fuentes, internas y externas. El proceso de análisis propio del equipo de inversión se traduce en puntuaciones que sirven para clasificar en el universo de inversión los puntos fuertes y débiles relativos a factores ESG de cada compañía. El equipo seguidamente ajusta sus valoraciones de las compañías para tener en cuenta estos riesgos y oportunidades ESG y el impacto que pueden tener en el valor liquidativo y las previsiones de flujos de caja de una compañía tanto a corto como a medio plazo. Sin embargo, los inversores deben tener en cuenta que el

resultado de este proceso de puntuación no es vinculante para la selección de inversiones que para el fondo realice el asesor de inversiones (a diferencia de las exclusiones vinculantes aplicables al fondo).

Como parte de sus procesos de diligencia debida, las inversiones propuestas del fondo se evalúan para comprobar su conformidad con los controles excluyentes vinculantes del fondo y por razón de incumplimiento de normas internacionales. El fondo no podrá adquirir aquellas compañías señaladas antes de las operaciones por su situación de cumplimiento (salvo que, con respecto a las exclusiones por razón de incumplimiento de normas internacionales, el asesor de inversiones considere que la compañía está tomando medidas adecuadas para su oportuna subsanación y mejora).

Políticas de implicación

El equipo de inversión por lo general se implica con los equipos de dirección de las compañías a intervalos regulares y, al hacerlo, tiene como fin impulsar cambios positivos, mejorar la sostenibilidad y potenciar la creación de valor a largo plazo. En el marco de este proceso de implicación, el equipo de inversión valora cómo los riesgos y las iniciativas ESG de las compañías pueden contribuir al rendimiento operativo y, entablando conversaciones con estas, evalúa diversidad de cuestiones medioambientales, sociales y de gobierno.

Tiivistelmä

Rahasto myös sulkee pois tietyt yritykset, jotka ovat kokeneet huomattavia kestävyteen liittyviä kiistanalaisuuksia, tai jotka rikkovat kansainvälisiä normeja (ellei rahastonhoitaja joka tapauksessa katso, että yritys toteuttaa asianmukaisia korjaus- ja parannustoimia).

Sijoitusstrategia

Rahaston sijoitustavoitteena on pitkän aikavälin pääoman arvon nostaminen sijoittamalla ensisijaisesti sellaisten yhdysvaltalaisen kiinteistötoimialan yritysten osakkeisiin, jotka sijaitsevat Yhdysvalloissa. Rahasto saavuttaa ympäristö- ja yhteiskuntavaatimuksensa yhteiskunnallisten poissulkemisten ja kansainvälisiin normeihin perustuvien poissulkemisten avulla alla kuvatun mukaisesti.

Osana bottom-up-fundamenttien tutkimusprosessiaan rahastonhoitaja arvioi järjestelmällisesti liikkeeseenlaskijan hallinnointi- ja ohjausjärjestelmän sekä liiketoimintakäytännöt.

Vähintään 80 prosenttia sijoituksista on ympäristöön tai yhteiskuntaan liittyvien ominaisuuksien mukaisia. Nämä sijoitukset tarjoavat suoran altistumisen sijoituksen kohteena

oleville yrityksille, mukaan lukien sijoitukset kiinteistösijoitusyhtiöihin.

Nämä prosenttiosuudet mitataan sijoitusten arvon mukaan.

Ympäristöön tai yhteiskuntaan liittyvien ominaisuuksien seuranta

Ympäristö- ja yhteiskuntateemoja seurataan yhdistelemällä työkaluja/seulontoja, salkunseurantatyökaluja sekä manuaalista tarkastusta ja analyyseja.

Rahastonhoitajan compliance-, riski- ja salkunvalvontatiimit suorittavat sijoitustiimin kanssa säännöllisiä salkku- ja tulostarkastuksia sekä järjestelmäkontrolleja varmistaakseen, että salkun sijoitustavoitteita sekä ympäristö- ja yhteiskuntateemoja noudatetaan.

Menetelmät

Poissulkemisrajojen noudattamista mitataan rahaston sellaisten sijoitusten prosenttiosuuden perusteella, jotka ovat poissulkemisrajojen vastaisia. Asiaankuuluva kestävyysindikaattori on siten se, että nolla (0) prosenttia rahaston sijoituksista on vastoin rahaston poissulkevia seulontoja.

Tietolähteet ja tietojen käsittely

Rahastonhoitaja hyödyntää ulkopuolisilta toimittajilta saatuja ESG-tietoja. Nämä tiedot kerätään ja niitä säilytetään Morgan Stanleyn keskitetyssä ESG-tietovarastossa, jotta Morgan Stanleyn liiketoimintayksiköillä, mukaan lukien MSIM-sijoitusryhmät, on pääsy tietoihin tutkimusta, salkkuanalyseja ja salkun rakentamista sekä asiakasraportointia ja sääntelyn edellyttämää raportointia varten. Tietojen kattavuudessa olevien puutteiden takia pieni osa tiedoista, joita käytetään ympäristö- ja yhteiskuntateemojen mukaisuuden arviointiin, on arvioita.

Menetelmiä ja tietoja koskevat rajoitukset

Alla esitetään joitakin keskeisiä aiheita ja yhteneväisyyksiä, jotka edistävät rajoituksia rahaston menetelmissä ja/tai tiedoissa ja/tai tietojen heikkoa laatua:

- menetelmiin liittyvät erot toimittajien välillä;
- tietojen laahaaminen jäljessä, eli tietojen raportointiaikataulut eivät ehkä ole

yhdenmukaisia SFDR-
raportointiaikataulujen kanssa, ja

- tietojen kattavuudessa olevat puutteet, jotka liittyvät omaisuusluokkiin, maantieteellisiin alueisiin ja markkina-arvoihin.

Rahastonhoitaja ryhtyy kohtuullisiin toimiin sen varmistamiseksi, että rahasto pystyy saavuttamaan ympäristöön ja yhteiskuntaan liittyvät ominaisuudet näistä rajoituksista huolimatta.

Asianmukainen huolellisuus

Rahaston vastuullinen sijoitusryhmä käyttää kestävyystutkimukseen mosaiikkilähestymistapaa. Se käyttää sekä kvantitatiivisia että kvalitatiivisia tietoja eri lähteistä, niin sisäisistä kuin ulkoisistakin. Sijoitusryhmän oman tutkimusprosessin tulokset näytetään pistetaulukossa, jossa ovat sijoitusuniversumiin kuuluvan kunkin yrityksen ESG-tekijöitä koskevat suhteelliset vahvuudet ja heikkoudet. Ryhmä muokkaa sitten yritysten arviointeja ottaakseen huomioon nämä ESG-riskit ja -mahdollisuudet ja sen vaikutuksen, joka niillä voi olla yritykset nettovarallisuusarvoon ja kassavirtaennusteisiin lyhyellä ja keskipitkällä aikavälillä. Sijoittajien olisi kuitenkin huomattava, että pistetaulukon tuotokset eivät ole rahastonhoitajan sijoitusten valintaa sitovia (toisin kuin rahastoon sovellettavat sitovat poissulkemiset).

Rahaston ehdotetut sijoitukset seulotaan rahaston sitovien poissulkevien seulontojen noudattamisen varalta rahaston sitovien poissulkevien seulontojen ja kansainvälisiin normeihin perustuvien poissulkemisten avulla. Rahasto ei saa ostaa yritystä, joka on merkitty kauppaa edeltävän vaatimusten mukaisuuden osalta (jollei rahastonhoitaja katso kansainvälisiin normeihin

perustuvien poissulkemisten osalta, että yritys toteuttaa asianmukaisia korjaus- ja parannustoimia).

Vaikuttamispolitiikat

Sijoitusryhmä harjoittaa yleistä vuoropuhelua yrityksen johdon kanssa säännöllisin väliajoin, ja pyrkii näin vauhdittamaan positiivista muutosta, parantamaan kestävyyttä ja lisäämään pitkän aikavälin arvonluontia. Tämän vuoropuheluprosessin osana sijoitusryhmä arvioi, kuinka yrityksen ESG-riskit ja -aloitteet voivat vaikuttaa toiminnan tuloksellisuuteen, ja arvioivat keskustelujen avulla ympäristöön, yhteiskuntaan ja hyvään hallintotapaan liittyvien aiheiden kattavuuden.

Nimetty vertailuarvo

Beleggingsstrategie

Minstens 80% van de beleggingen van het Fonds liggen op één lijn met milieu- of sociale kenmerken. Deze beleggingen bieden directe blootstelling aan entiteiten waarin wordt belegd, met inbegrip van beleggingen in vastgoedbeleggingstruists (of REIT's).

Deze percentages worden gemeten volgens de waarde van de beleggingen.

Monitoring ecologische of sociale kenmerken

De milieu- en sociale kenmerken worden gecontroleerd met een combinatie van instrumenten/screens, instrumenten voor portefeuillebewaking en handmatige documentaire beoordelingen en analyses.

De teams Compliance, Risk en Portfolio Surveillance van de beleggingsadviseur werken samen met het beleggingsteam om regelmatig portefeuille-/prestatiebeoordelingen en systemische controles uit te voeren om ervoor te zorgen dat de beleggingsdoelstellingen van de portefeuille en de milieu- en sociale kenmerken worden nageleefd.

Methodologieën

De toepassing van de uitsluitingscreens op de beleggingen van het fonds wordt gemeten aan de hand van het percentage van de beleggingen van het fonds dat de uitsluitingscreens schendt. De relevante duurzaamheidsindicator die wordt gevolgd door het Fonds is derhalve dat 0% van de beleggingen van het Fonds in strijd is met de uitsluitingscreens.

Databronnen en -verwerking

De Beleggingsadviseur maakt gebruik van ESG-gegevens van diverse externe leveranciers. Deze gegevens worden verzameld en opgeslagen in de gecentraliseerde ESG-gegevensopslagplaats die elke afdeling van Morgan Stanley, inclusief de beleggingsteams van MSIM, toegang verstrekt tot de informatie voor onderzoek, portefeuilleanalyse en -opbouw, en rapportage aan cliënten en toezichthouders. Als gevolg van lacunes in de gegevensdekking wordt een klein deel van de gegevens die worden gebruikt om de afstemming op de ecologische / sociale kenmerken te beoordelen, geschat.

Methodologische en databeperkingen

Hieronder worden enkele van de belangrijkste thema's en overeenkomsten geschetst die

bijdragen tot beperkingen in de methode en/of een slechte gegevenskwaliteit van het Fonds:

- methodeverschillen tussen gegevensleveranciers;
- gegevens lopen achter, d.w.z. dat de tijdschema's voor de rapportage van de gegevens niet altijd overeenstemmen met de tijdschema's voor de rapportage van de SFDR; en
- lacunes in de gegevensdekking in activaklassen, regio's en marktkapitalisaties.

De subbeleggingsadviseur neemt redelijke maatregelen om ervoor te zorgen dat het fonds ondanks deze beperkingen aan zijn milieu- of sociale kenmerken kan voldoen.

Due diligence

Het beleggingsteam dat verantwoordelijk is voor het Fonds hanteert een mozaïekbenadering van duurzaamheidsonderzoek, waarbij zowel kwantitatieve als kwalitatieve gegevens uit verschillende bronnen, zowel intern als extern, worden gebruikt. Het eigen onderzoeksproces van het beleggingsteam resulteert in een score die de relatieve sterke en zwakke punten van elk bedrijf in het beleggingsuniversum op ESG-factoren rangschikt. Vervolgens past het team zijn waarderingen van de bedrijven aan om rekening te houden met deze ESG-risico's en -kansen, en de impact die ze kunnen hebben op de intrinsieke waarde en de kasstroomprognoses van een bedrijf op korte en middellange termijn. Beleggers dienen er echter rekening mee te houden dat de output van dit scorecardproces niet bindend is voor de selectie van beleggingen voor het Fonds door de Beleggingsadviseur (in tegenstelling tot de bindende uitsluitingen die op het Fonds van toepassing zijn).

Als onderdeel van de due diligence-processen worden de voorgestelde beleggingen van het Fonds gescreend op naleving van de bindende

Engagementbeleid

Het beleggingsteam overlegt doorgaans op gezette tijden met de bedrijfsleiding en streeft daarbij naar positieve verandering, meer duurzaamheid en waardecreatie op lange termijn. Fondet fremmer sosiale egenskaper ved å unngå investeringer i visse aktiviteter som kan skade menneskers helse og velvære eller være skadelig for sosial samhørighet. Fondet ekskluderer også enkelte selskaper som har opplevd betydelige bærekraftsrelaterte kontroverser, eller som bryter med internasjonale normer (med mindre investeringsrådgiveren i hvert enkelt tilfelle vurderer at selskapet tar passende skritt for vesentlig utbedring og forbedring).

Investeringsstrategi

Fondets investeringsmål er å søke langsiktig kapitalvekst ved å investere primært i aksjer i selskaper i den amerikanske eiendomsbransjen lokalisert i USA. Fondet oppfyller sine miljømessige og sosiale egenskaper gjennom anvendelse av sosiale utelukkelse og utelukkelse basert på internasjonale normer, som beskrevet nedenfor.

Overvåking av miljømessige eller sosiale egenskaper

De miljømessige og sosiale egenskapene overvåkes ved hjelp av en kombinasjon av verktøy/utsilingsmekanismer, porteføljeovervåkingsverktøy og manuelle gjennomganger av dokumentasjon og analyse.

Investeringsrådgiverens etterlevelsese-, risiko- og porteføljeovervåkingsteam samarbeider med investeringsteamet for å gjennomføre regelmessige portefølje-/verdiutviklingsgjennomganger og systemkontroller for å sikre etterlevelse mht. porteføljens investeringsmål og miljømessige og sosiale egenskaper.

Metoder

Bruken av utsilingsmekanismer på fondets investeringer måles ved prosentandelen av fondets investeringer som bryter med utsilingsmekanismene. Den relevante bærekraftsindikatoren som fondet overvåker, innebærer derfor at 0 % av fondets investeringer skal være i strid med fondets retningslinjer for utsiling.

Datakilder og -behandling

Investeringsrådgiveren utnytter ESG-data fra ulike eksterne leverandører. Disse dataene samles inn og lagres i Morgan Stanleys sentraliserte ESG-datalager, slik at enhver forretningsenhet hos Morgan Stanley, deriblant MSIM-investeringssteam, har tilgang til informasjonen for analyse, porteføljegjennomgang og -oppbygning samt klient- og regelverksrapportering. På grunn av hull i datadekningen er en liten andel av dataene som brukes til å vurdere etterlevelse mht. miljømessige/sosiale egenskaper, estimerte data.

Begrensninger i metoder og data

Nedenfor skisseres noen av hovedtemaene og fellestrekkene som bidrar til begrensninger i metoder og/eller data og/eller dårlig datakvalitet for fondet:

- metodikkforskjeller mellom dataleverandører
- dataforsinkelser, dvs. at rapporteringstidslinjer for data ikke

stemmer overens med SFDR-rapporteringstidslinjer, og

- datadekningshull som omfatter flere aktivaklasser, geografier og markedsverdier.

Investeringsrådgiveren treffer rimelige tiltak for å sikre at fondet er i stand til å oppfylle sine miljømessige eller sosiale egenskaper til tross for disse begrensningene.

Due diligence

Investeringsteamet som er ansvarlig for fondet foretar en mangefasettert tilnærming til bærekraftsanalyse, ved å anvende både kvantitative og kvalitative data fra ulike kilder, både interne og eksterne. Investeringsteamets proprietære analyseprosess resulterer i en poengscore som rangerer de sterke og svake sidene ved hvert selskap i investeringsuniverset mht. ESG-faktorer. Teamet justerer deretter sine verdivurderinger av selskapene for å ta hensyn til disse ESG-risikoene og mulighetene samt innvirkningen de kan ha på et selskaps netto aktivaverdi og kontantstrømprognoiser på både kort og mellomlang sikt. Investorene bør imidlertid merke seg at resultatet av denne scoreprosessen ikke er bindende for investeringsrådgiverens valg av investeringer for fondet (i motsetning til de bindende utelukkelsene som gjelder for fondet).

Som en del av sine due diligence-prosesser, blir fondets foreslåtte investeringer screenet for samsvar med fondets bindende utelukkelse og utsiling basert på internasjonale normer. Et selskap som er flagget for førhandelsovertredelser, tillates ikke kjøpt av fondet (med mindre investeringsrådgiveren, under hensyntagen til utelukkelse basert på

internasjonale normer, anser at selskapet tar passende skritt for vesentlig utbedring og forbedring).

Retningslinjer for engasjement

Investeringsteamet engasjerer seg generelt med jevne mellomrom med selskapsledelsen og søker på den måten å være pådriver for positive endringer, forbedre bærekraften og forbedre langsiktig verdiskaping. Estratégia de investimento

O Fundo cumpre as respetivas características ambientais e sociais através da aplicação de exclusões sociais e exclusões relativamente a normas internacionais, conforme descrito mais adiante.

Como parte do respetivo processo ascendente de investigação fundamental, o Consultor de Investimentos incorpora sistematicamente uma avaliação da governação empresarial e das práticas comerciais de um emitente.

Pelo menos 80% dos investimentos do Fundo estão alinhados com características ambientais ou sociais. Estes investimentos oferecem exposição direta às entidades onde se investe, incluindo a SII (sociedades de investimento imobiliário, REIT na sigla inglesa).

Estas percentagens são calculadas de acordo com o valor dos investimentos.

Monitorização das características ambientais ou sociais

As características ambientais e sociais são monitorizadas mediante a utilização de uma combinação de ferramentas/filtros, ferramentas de supervisão das carteiras e análises e revisões documentais manuais.

As equipas de Conformidade, Risco e Supervisão de Carteiras do Consultor de Investimentos colaboram com a equipa de investimento na realização de análises periódicas da carteira/do desempenho e de verificações sistémicas para garantir o cumprimento dos objetivos de investimento da carteira e das características ambientais e sociais.

Metodologias

A aplicação dos filtros de exclusão aos investimentos do Fundo é calculada por percentagem dos investimentos do Fundo que violam os filtros de exclusão. O indicador relevante de sustentabilidade monitorizado pelo Fundo pretende, portanto, que 0% dos investimentos do Fundo violem os filtros de exclusão.

Fontes e tratamento dos dados

O Consultor de Investimentos tira partido de dados ASG de fornecedores externos. Estes dados são recolhidos e armazenados no repositório centralizado de dados ASG da Morgan Stanley para que todas as unidades de negócio da Morgan Stanley, incluindo as equipas de investimento da MSIM, tenham acesso às informações para efeitos de investigação, análise e constituição de carteiras, e para comunicação de informações a clientes e de natureza regulamentar. Devido a lacunas na cobertura dos dados, uma pequena proporção dos dados utilizados para avaliar o alinhamento com as características ambientais/sociais são dados estimados.

Limitações da metodologia e dos dados

Adiante descreve-se alguns dos principais temas e pontos em comum que contribuem para as limitações das metodologias e/ou dos dados do Fundo e/ou fraca qualidade dos mesmos:

- diferenças metodológicas entre os fornecedores dos dados;
- defasamentos dos dados, ou seja, a linha cronológica de comunicação dos dados pode não estar alinhada com a calendarização de divulgação estipulada no SFDR; e
- lacunas na cobertura dos dados relativos a classes de ativos, geografias e capitalizações bolsistas.

O Consultor de Investimentos toma medidas razoáveis para garantir que o Fundo é capaz de cumprir as suas características ambientais ou sociais apesar destas limitações.

Diligência devida

A equipa de investimento responsável pelo Fundo aborda a pesquisa da sustentabilidade como uma manta de retalhos, utilizando dados quantitativos e qualitativos de várias fontes, tanto internas como externas. O resultado do processo de pesquisa realizado pela equipa de investimentos traduz-se num painel de avaliação onde são classificados os pontos fortes e fracos relativos a cada empresa no universo de investimento quanto aos fatores ASG. A equipa ajusta depois as respetivas valorizações das empresas tendo em conta estes riscos e oportunidades ASG e o impacto que estes podem ter no valor patrimonial líquido e nas previsões de fluxo de caixa das empresas, tanto no curto como a médio prazo. Os investidores devem ter em atenção, contudo, que o resultado do processo deste painel de avaliação não é vinculativo quanto à seleção dos investimentos para o Fundo por parte do Consultor de Investimentos (ao contrário das exclusões vinculativas aplicadas ao Fundo).

Como parte do processo de diligência devida, os investimentos propostos pelo Fundo são escrutinados quanto à conformidade com os filtros

de exclusão vinculativos do Fundo e as exclusões relativas a normas internacionais. Uma empresa que seja assinalada a nível da conformidade antes de ser negociada, não poderá ser alvo de compra pelo Fundo (salvo se, no que diga respeito às exclusões relativas a normas internacionais, o Consultor de Investimentos considerar que a empresa em causa está a dar os passos apropriados para corrigir a situação e implementar melhorias substanciais).

Políticas de envolvimento

A equipa de investimento interage por norma com a administração da empresa de forma regular e, nesse sentido, pretende impulsionar mudanças positivas, melhorar a sustentabilidade e reforçar a geração de valor a longo prazo. Nesse processo de interação, a equipa de investimento avalia a forma como os riscos e iniciativas ASG da empresa podem contribuir para o desempenho operacional e, através do diálogo, coloca à consideração uma série de tópicos ambientais, sociais e de governança.
